Summary

After an expected demand contraction in 2009, global aluminium demand is estimated to see a revival in 2010 on the back of an expected marginal recovery in developed countries and moderate growth in China and India. Correspondingly, after the sharp decline in 2009, average international aluminium prices are also expected to inch up in 2010.
