Name of the Entity forming part of the amalgamation/ merger, details in brief such as size, turnover etc.	CRISIL Risk is a wholly owned subsidiary of CRISIL and had total income of INR 9,527.41 lakhs for the year ended December 31, 2020. Pragmatix is a wholly owned subsidiary of CRISIL and had total income of INR 4,232.31 lakhs for the year ended December 31, 2020. CRISIL had a total income of INR 99,273 lakhs for the year ended December 31, 2020.
2.	Whether the transaction would fall within related party transaction(s)? If yes, whether the same is done at arms-length	Yes, the transaction would fall within related party transactions. CRISIL Risk and Pragmatix are wholly owned subsidiaries of CRISIL. Since, the Scheme involves a merger of wholly owned subsidiaries with the parent holding company, no shares would be issued pursuant to the merger.
		The Ministry of Corporate Affairs has clarified vide its General Circular No. 30/2014 dated July 17, 2014 that transactions arising out of Compromise, Arrangements and Amalgamations dealt with under specific provisions of the Companies Act, 2013, will not fall within the purview of related party transaction in terms of Section 188 of the Companies Act, 2013.
		Similarly, compliances under Regulation 23 of the Listing Regulations for related party transactions is not applicable to the proposed Scheme.
3.	Area of business of the entities	CRISIL Risk is engaged in the business of providing risk solutions and advisory services.
		Pragmatix is engaged in the business of providing sofitware products and services in areas of business intelligence and analytics, and consulting/implementation services.
