The key raw materials required include raw gold and silver. The firm imports gold and silver dore bars with AU content below 95% as per the norms stipulated by the Directorate General of Foreign Trade (D.G.F.T), from South Africa, Hong Kong, and South America, which account for 100.00 per cent of the firm's total purchase and the transactions are valued in USD. The firm has an installed capacity for processing of raw gold around 30 metric tonnes per year, and 270 metric tonnes of silver per year.
